

ORDER GRANTING CONVERSION FROM CHAPTER 13 TO CHAPTER 11

Pursuant to 11 U.S.C. § 706(a), the above named Debtor(s) request this court to convert this case under Chapter 13 to a case under Chapter 11, and as grounds states as follows:

1. As order for relief under Chapter 13 of the Bankruptcy Code was entered on 09/01/2010.
